Context & Session Description

The world is waking up to the need to convserve the world's soils health in order to contribute to the 2030 Sustainable Development Goals and address imminent global challenges: climate change, ecosystem degradation and food security.

The science is clear and the economic case strong: soil health is the foundation of our food system; it boosts the resilience of farms and supply chains to the effects of increased climate variability. Businesses collaborating in the WBCSD Food & Nature Program together with expert partners step up to address this need through action on investment with farmers and producers in soil health and sustainable landscapes.

This session aims to (1) enhance recognition of the multiple dimensions of benefits of investment in soil health beyond acting as carbon sinks, of sustainable landscapes, their simultaneous contribution to the objectives of 3 UN conventions: UNFCCC, UNCBD and UNCCD, (2) showcase transformative investments that support implementing action in soil health and sustainable landscapes, (3) and what are the critical barriers and lessons to be shared and learned to scale and accelerate investments into soil health action.
