Questions:

Peter Bentley (8 mins):

You and I last saw each other at the Bonn Intersessional meetings in early June, the mid-way point to COP28. We are all hoping for a global goal for adaptation to be agreed by December this year. How are we doing on that front? Are we on the right track as a global community? Where do you see particular challenges and are there any positive predictions you could make?

Sasha Abraham (8 mins):

The Climate Change Committee is an organization that critically assesses the UK's climate change strategy, and you were one of the authors of the latest report on COP27: Key outcomes and next steps for the UK. What did your report find when it comes to the UK's role as a global leader in climate change, especially when we look at adaptation. Can the UK still be called a leader? Why is that so?

Vidhisha Samarasekara (8 mins):

Turning to the aspect of research, development and innovation. Where is there an opportunity in the kind of research you do in London that could be of benefit for farmers in the UK as well as smallholder farmers in the Global South? Can you please give us some best practice examples? Where do you see more need for research in particular?

All (4 mins each):

At the moment it isn't likely that the global community will achieve the 50:50 split between financing of mitigation measures and adaptation. The London Climate Action Week very much represents the continuous focus on mitigation as well. On top of that, we just heard the former Secretary-General of the United Nations, Ban Ki-moon mention that of the overall funds for adaptation, only 1.7 % really end up with smallholder farmers in the global south.

Where do you personally see an opportunity for the UK to take on a more prominent role in supporting the most vulnerable to adapt to climate change?

Why do you think that climate adaptation still doesn't get the same amount of attention from the global community as mitigation does? What can we all – civil society, academia, think tanks, governments, and the private sector – do to help give elevate the topic, especially when it comes to supporting smallholder farmers?

Speaker Bios:



Sasha Abraham is the Senior Analyst for International Climate Action at the UK's Climate Change Committee (the CCC). Within the CCC's wider work of assessing and advising on the UK Government's progress on climate change, Sasha focuses on exploring what international climate leadership looks like for the UK, assessing the impact of global shifts on the UK's domestic decarbonisation and adaptation efforts

and sharing lessons from the CCC's journey with countries across the world. From 2020 - 2022, she covered climate diplomacy and negotiations in the office of the COP26 President, the Rt Hon Sir Alok Sharma KCMG MP and has previously worked on climate and research across several Government departments.



Peter Bentley is the Head of the Adaptation and Resilience team at the UK's Foreign, Commonwealth and Development Office (FCDO). In this role he manages a team covering adaptation policy and programs, as well as the adaptation and loss and damage UNFCCC negotiations for the FCDO. He previously led on disaster risk financing and insurance for the FCDO and helped set up the Centre for Disaster Protection, which

aims to find better ways to stop disasters devastating lives and economies, by supporting countries to better manage disaster risk. Prior to this he worked in humanitarian response for Save the Children, working across East Africa in South Sudan, Uganda, Kenya and Ethiopia on first phase and chronic emergencies.





Dr. Vidhisha Samarasekara is the Strategic Program Director – Water Climate Change and Resilience. At IWMI, Vidhisha provides scientific leadership and overall direction for the program, champions its vision, inspires, and guides multi-disciplinary teams addressing climate change adaptation, climate-smart agriculture, water risk management, disaster risk reduction and resilience to water-related drivers of fragility

and societal disruption. Before IWMI Vidhisha held senior staff positions with the Asian Development Bank (ADB) where she contributed towards the development of key climate change adaptation policy and legislation development across South Asia. She has designed and led major environmental and climate finance initiatives with support from the Global Environment Facility (GEF), Climate Investment Fund (CIF), and UKAid. Vidhisha also served as Director for KPMG's International Development Advisory Services in East Africa where she oversaw the delivery of UKAid to the BRACED program (Building resilience and adaptation to climate extremes and disasters program) which provided funding for non-governmental organizations (NGOs) to build the resilience of people to extreme climate events in selected countries in the Sahel, Sub-Saharan Africa and South Asia.



Tabitha is founder of a women-owned agri-enterprise, Tabikon Solutions, in Gatundu North Subcounty, Kenya. Macadamia, pineapples and avocados are amongst the crops cultivated there. The enterprise seeks to be at the forefront of practical actions to sustainably increase agricultural productivity and incomes of farmers locally. It strives to achieve this by aggregating produce from local farmers, offering an extra market and income to these local farmers. Additionally, indigenous trees are now

being grown on their land to act as carbon sinks.



Dr. Márcia Balisciano leads corporate responsibility at RELX Group, a global provider of information and analytics focused on science and health, risk and business, legal and exhibitions, with more than 30,000 employees and offices in 40 countries. Chair of the United Nations Global Compact UK and the UK National Crime Agency's Child Rescue Alert Development Board, she is founding director of London Museum and
