Sindh cabinet approves writing off Rs. 7.2 bn loans KARACHI: The provincial cabiloan of Rs. 7,204,280,508 outstand-The record is also made availin Deh Nando Kohistan, Taluka

net on Thursday decided to write off Rs7.2 billion old loans advanced to different government departments and organizations and launch e-registration, e- mutation, and e-crop assessment project under the Board of Revenue.

The meeting chaired by Sindh Chief Minister Sayed Murad Ali Shah also decided to allot land for the establishment of state-of-art Industrial Enclaves in Hyderabad and Sukkur.

for Information Minister Sharjeel Inam Memon, after the cabinet meeting, addressed a press conference and shared the decisions taken by the cabinet.

The finance dept briefing the cabinet on old loans for which the record was untraceable, said that Rs7.2 billion loans advanced from 19982-83 to 2012-13 to the government department and organization may be written off as recommended by the Public Accounts Committee (PAC) and sub-committee on Finance.

The cabinet was told that Rs. 174.863 million loans advanced to private parties for the period from financial year 1982-83 to 1992-93 were also long outstanding for which the record is neither traceable nor recoverable.

The cabinet discussed the matter and approved the writing off the

Rolin located between National Highway and Motorway Road. The market price of land has been fixed at Rs 5 million per acre. Minister Local Government

Syed Nasir Shah suggested that the land should be given to the Investment Department free of cost as the proposed industrial estate would generate employment opportunities and boost the economy.After a detailed discussion, it was decided to fix the price of the land at 25 per cent of the market rate and the request of the SEZMC was approved.

The SEZMC also requested the cabinet for the allotment of 451.37 acres of state land at Deh Goondar situated on the Hyderabad-Tando Mohammad Khan dual carriageway and another 500 acres at Deh Ganjo Takkar, Taluka Latifabad, Hyderabad for the establishment of Industrial enclaves.

The revenue dept told the cabinet that the price of the lands has been fixed at Rs1,25 crores and Rs 1 core respectively. Protecting Your Eyes and Ears During the Summertime

ISLAMABAD: Summer is a time of fun and enjoyment, vacations, camp, and family trips. But many popular activities of summer, such as swimming, can have safety risks, especially to the eyes and ears.

Usiwoma Abugo, MD, an ophthalmologist in Norfolk, VA, and a spokesperson for the American Academy Ophthalmology, shares the story of "Linda," 16-year-old who recently consulted her because her right eye was red, irritated, and severely painful in sunlight. (Abugo changed the patient's name and identifying information to protect her privacy.) Linda had no history of trauma, and nothing like this had ever happened to her before. She also had no illnesses that could account for these symptoms.

"When we stained the eye with a special dye that picks up defects on the surface of the eye, we found that she had a corneal ulcer," Abugo said.

Linda usually wore contact lenses but couldn't put them in. due to the pain in her right eye. She told Abugo that she occasionally swam with her contacts in because she's "blind without them."

How to Protect Your Eyes From the Sun

The sun's so bright, you gotta wear shades. Here are some simple ways to avoid those harmful rays.

Swimming with contact lenses is dangerous, Abugo said. Bacteria can grow on the lenses and cause serious infections. Linda needed more tests to see what organism was causing the problem.

"Because she had a visionthreatening central corneal ulcer, she had to put in eyedrops every hour until improvement was noted, and she had to be seen daily in clinic to make sure she was improving - or, more importantly, not declin-

ing," Abugo said. Linda ended up with a scar through part of her visual axis. "Further consideration is being done to decide whether she will need a corneal transplant in order to restore her vision," Abugo said.

This injury could have been prevented by not swimming with contact lenses. Instead, Abugo said, people should wear prescription goggles - if you can afford them.

Caring for the Eyes During Summertime

A new study published in the August issue of Ophthalmic Epidemiology looked at patterns of internet searches for eye symptoms, such as redness, dryness, pinkeye, and pain. The researchers analyzed publicly available Google Trends data from the United States from Jan. 1, 2015, to Dec. 31, 2019. Close to half of the searchers (45%) had seasonal patterns. For example, searches for eye redness peaked in the springtime, which the authors suggest might be connected with the peak time for allergies. Searches for eye pain were highest during the summertime, which they suggested might be linked to eye trauma. Fireworks are a common cause of eye trauma, Abugo said. "Fireworks are beautiful but can also be blinding due to eye rupture, surface scratches, and burns, so ensure that you leave the handling of them to professionals," she said. "If you're in the presence of fireworks, even as a bystander, you should wear eye protection," she continued.

BEIJING: International Airlines (PIA) will celebrate 60 years of flying to the People's Republic of China, next year.

With the inaugural flight between Karachi and Shanghai via Guangzhou (Canton) on April 29, 1964, with a Boeing 720B, the national flag carrier earned the distinction of becoming the first airline from a non-communist country to fly into China, official sources told APP here on Wednesday.

Later, in addition to flights operated between Islamabad and Beijing, passengers also enjoyed direct and convenient access to Tokyo, Japan via Beijing and Hong Kong via Bangkok.

At present, passengers travelling by PIA can fly between Pakistan and 16 captivating cities of China via Beijing in partnership with Air China.

These cities include Guangzhou, Shanghai, Wuhan, Chongqing, Chengdu, Changchun, Hangzhou and Harbin etc. During the Covid-19 pandemic, PIA was among the few airlines which continued its flight operation to different cities of China. PIA operated its special flights from Islamabad to Beijing, Xian, Shanghai, Chengdu, Wuhan and Tianjin to facilitate passengers travelling between Pakistan and China. It also airlifted Covid-19 vaccine from China to Pakistan through special flights during the pandemic. 

Daily Low-Dose Aspirin Can Increase Risk of **Brain Bleeding**

ISLAMABAD: Daily lowdose aspirin may increase the risk of bleeding inside the skull in older adults, while doing little to lower their risk of ischemic stroke, new research shows. Ischemic strokes are the most commonTrusted Source type of stroke and happen when blood flow to the brain is blocked, such as by a blood

The study, published July 26 JAMA Network OpenTrusted Source, adds to growing evidence that routine aspirin use for older adults who haven't had a previous stroke carries more risk than benefit.

Taking a daily low-dose aspirin is a common and effective strategyTrusted Source for preventing a heart attack or stroke in people who have had a previous heart attack, stroke or other cardiovascular disease event.

But some people without cardiovascular disease take a daily aspirin, thinking it will prevent a first heart attack or stroke - in 2017, approximately 29 million AmericansTrusted Source fell into this category. Nearly 7 million did so without their healthcare provider's recommenda-

The new study suggests that "we're not really getting the benefit of reducing potential stroke and cardiovascular disease with low-dose aspirin," said Dr. Ched Nwagwu, neurosurgeon and medical director of MemorialCare Saddleback Medical Center's Stroke Program in Laguna Hills, Calif., who not involved with

the new research. "And, certainly in older patients, there's emerging data that [people taking daily lowdose aspirin] are more prone to

bleeding," he told Healthline. However, Nwagwu cautioned that more studies are

needed to confirm these results. "We can't base our entire [clinical] practice just on this one trial," he said.

Risks and benefits of lowdose aspirin

Aspirin thins the blood and helps prevent blood clots in the arteries that can cause a heart attack or stroke. But the bloodthinning quality of aspirin can also cause bleeding in the gastrointestinal tract or a stomach ulcer.

Earlier clinical trials have found that while routine use of low-dose aspirin reduced the risk of heart attack and stroke, it also increased the risk of bleeding, both in the stomach and intestines and inside the skull.

Older adults, in particular, are at higher risk of bleeding in the brainTrusted Source due to a ruptured blood vessel. They are also at high risk of fallsTrusted Source, which can lead to head trauma and bleeding in the skull.

Because of this, the authors of the new study wanted to investigate the risks and benefits of low-dose aspirin use in older adults without a history of heart attack, stroke or other cardiovascular disease event.

The trial included more than 19,000 people in Australia and the United States aged 70 years or older; or 65 years or older for U.S. participants who reported their race or ethnicity as Black or Hispanic,-Online

Dilemma of Hunger

Position of Pakistan on the Global Hunger Index is reminders that much work lies ahead to tackle this humanitarian crisis. The combat against hunger stresses firm commitment, innovative and inventive strategies, and collective action. It is the responsibility of the government, authorities, civil society, and affluent people alike to step up efforts and ensure that every citizen has access to sufficient, nutritious food. Together, we can transform this grave challenge into an opportunity to build a more resilient, nourished, and prosperous nation. Over an inordinate length of time, Pakistan has made some progress in reducing its GHI score, dropping from 38.1 in 2006 to 26.1 in 2022. However, this reduction is not enough to be complacent, as the score still places Pakistan in the category of "serious" hunger. A score of zero indicates no hunger, and while Pakistan's trajectory is promising, there is still a long way to go to ensure no one in the country goes to bed hungry. In the face of globalization and advancements in technology, it is disheartening to witness a fundamental issue like hunger still persisting in many parts of the world. The Global Hunger Index is an alarming reminder of the challenges faced by developing nations, and the recently released GHI-2022 ranking paints a bleak picture for Pakistan. The country's ranking of 99 out of 121 nations is a stark reminder of the urgency required to address this critical issue. It is no surprise that approximately 82.8 million people in Pakistan are forced to live in hunger, struggling to meet their daily nutritional needs. The report suggests that 46 countries, including Pakistan, are unlikely to eradicate hunger entirely by 2030. This projection is a wake-up call for Pakistan's policymakers to redouble their efforts in addressing the issue and ensuring that the country does not slip further down the list of hunger-stricken nations.

Within this region, Pakistan has one of the highest levels of hunger, exacerbating the problem of child malnutrition. Alarmingly, the rates of stunting and child wasting are also among the highest in the world. To confront this challenge effectively, Pakistan must prioritize hunger eradication and focus on implementing sustainable and targeted solutions. Government agencies, civil society, non-governmental organizations, and the private sector must come together in a collaborative effort to address the root causes of hunger in the country. First and foremost, ensuring access to adequate and nutritious food for all citizens should be the primary objective. This involves investing in agriculture and rural development to boost food production, as well as providing financial support to small farmers to help them grow more and better crops. Moreover, strengthening social safety nets and welfare programs is essential to support the most vulnerable segments of the population. This includes the implementation of school feeding programs to combat child malnutrition and improve educational outcomes.

Beyond national efforts, international cooperation and assistance are indispensable in the fight against hunger. Pakistan should actively engage with global organizations, donor countries, and international agencies to access funds, expertise, and knowledge necessary for effective hunger eradication programs.

Pakistan's membership in the SCO: A path to shared prosperity and security

The Shanghai Cooperation Organization has become an effective multilateral mechanism for regional states, as several states have applied for its membership. Full membership in the organization has enabled Pakistan to embark on a trajectory of shared prosperity, and common security, and become part of one of Asia's largest representative organizations. The membership of SCO has provided Pakistan with the opportunity to enhance its bilateral and multilateral engagement with various regional actors. Through multilateral diplomacy, Pakistan has been engaging with regional actors. The enhanced bilateral relationship with Russia and Iran is an instance of these developments. SCO is constructing a web of regional connectivity, and Pakistan's location greatly benefits it by being the epicenter of the trade and communication route.

The SCO offers a much-needed opportunity for Pakistan to become part of a legal normative multilateral forum through which Islamabad can engage with different regional actors. To begin with, the geopolitical significance of the Shanghai Cooperation Organization has increased Islamabad's geopolitical influence among its members due to its geostrategic location. Pakistan offers a natural link and route to SCO members to gain access to the Indian Ocean. Pakistan also provides a link between SCO countries, especially landlocked Central Asian Republics (CARs), Afghanistan, Xinjiang Province of China towards the South, i.e., Arabian Sea and the Middle East. Consequently, by virtue of its geopolitical location, Pakistan acts as a major artery for regional connectivity. The unique geographical location of Pakistan for interconnectivity has significantly increased its geopolitical significance among the SCO members. The imminent geopolitical location of Pakistan has afforded it the status of an essential actor. Islamabad views the organization of SCO as a giant that can offer geostrategic benefits. This can assist Pakistan in collaborating with the member states toward achieving peace, security and long-term economic affluence in the region. SCO has infused a new spirit and energy into the bilateral relationship between Pakistan and Russia. Pakistan's recent high-level official visit to

Russia further improved relations. Under the

renewed relations, Pakistan has received crude Russian oil at discounted prices. This clearly indicates that Pakistan has benefited from its membership in the Shanghai Cooperation Organization. Similarly, the progress of the China-Pakistan Economic Corridor (CPEC) and the completion and functioning of its major projects have also benefited Pakistan. CPEC is building a network of transportation, infrastructure and economic zones. This trade and investment structure of CPEC has made Pakistan a viable state for SCO member states to boost their economies through cooperation and collaboration. Pakistan's tilt towards the SCO nations seems to increasingly strengthen trade and economic cooperation, as evident in the case of Russia, Iran and Azerbaijan. The active participation in trade, security and other areas is becoming beneficial for Pakistan, especially at a time when its relations with the US are again sour. This clearly indicates that Pakistan's membership in the Shanghai Cooperation Organization has brought several benefits to the country both in economic and political terms.

Pakistan has been significantly affected by terrorism and a fragile security environment in Afghanistan. The SCO States are also vulnerable to terrorism and extremism. Pakistan, Russia, Iran and China have all expressed their concerns about the deteriorating situation in Afghanistan and the emergence of the terrorist organization known as the Islamic State in Iraq and Syria (ISIS). In terms of regional security, by collaborating with the SCO, Pakistan has a historical opportunity to combat the menace of terrorism. The Shanghai Cooperation Organization has recognized Pakistan's sacrifices and contribution against terrorism and extremism. This fits the framework of the SCO which endorses the fight against the three evils of terrorism, extremism and separatism. In 2022, the Samarkand Declaration emphasized initiatives for cooperation in countering terrorism and recognized Pakistan's efforts. Nuclear safety & security: Pakistan outranks India

LAST week, a US-based international organization, Nuclear Threat Initiative (NTI) in its latest report (2023) - while evaluating the status of global nuclear security - has ranked Pakistan above India in terms of its handling of hazardous nuclear material. Whereas, the IAEA has acknowledged Pakistan's efforts on nuclear security and the NTI in its 2020 report, also endorsed Pakistan's progress, declaring Pakistan as the most improved country in the theft ranking for countries with nuclear materials. Thus, it is justifiably argued, "Pakistan's nuclear capabilities are the safest and most secure in the world, with zero incidents of any theft or missing nuclear materials, like its eastern neighbour, India, where such incidents are often reported." Because of its prompt and comprehensive nuclear security mechanism, Pakistan dominates the South Asian region in terms of nuclear safety and security. Every year, NTI releases its annual report on nuclear safety and security index which measures countries' nuclear security capabilities and efforts based on a set of indicators and criteria- highlighting the security of nuclear materials and facilities; the adherence to international norms and treaties; the regulatory framework for nuclear security; and implementation of the best practices to prevent unauthorized access to nuclear weapons or materials. Currently, the NTI index revealed in the tabulated form Pakistan's total score of 49 which was higher than India's 40, Iran's 29 and North Korea's 18. Pakistan is ranked 32 along with Russia and Israel in terms of the security of its nuclear facilities and is above India, Iran, Mexico, South Africa and several others on a list of 47 countries. Stabilized nuclear safety, security mechanism in Pakistan: As a nuclear capable state, Pakistan takes its nuclear security responsibility very seriously. The security of nuclear weapons remains the core responsibility of Pakistan's National Command Authority (NCA). For years, the NCA's Secretariat, Strategic Plans Division (SPD) has been fully committed to ensuring nuclear safety and security. Pakistan has adopted the best available measures to enhance its security on both domestic and international levels. Domestically, Pakistan's Strategic Export Control Act 2004 enables the government to control the export, re-export, trans-shipment and transit of goods, technologies,

materials and equipment that may contribute to the designing, development, production, stockpiling maintenance or use of nuclear and biological weapons and their delivery systems. Pakistan has also established a specially trained, highly skilled and well-equipped force specifically for the physical security of its nuclear installations. As part of its national detection architecture, Pakistan has deployed radiation detection equipment at various entry and exit points to deter, detect and prevent illicit trafficking of nuclear and radioactive materials. Nuclear safety and security in Pakistan are based on multiple layers and defence-in-depth concepts. Pakistan has successfully implemented International Atomic Energy Agency (IAEA)-Pakistan nuclear security cooperation program. Several projects have been successfully implemented for capacity enhancement in nuclear security. For capacity building, Pakistan's Centre of Excellence on Nuclear Security (PCENS) was established with US support through the IAEA. The National Institute of Safety and Security (NISAS) and the Pakistan Institute of Engineering and Applied Sciences (PIEAS) are also important contributors to capacity building and professional development. Moreover, Pakistan has also been working with the Global Initiative to Combat Nuclear Terrorism (GICNT) in different areas, including the development of GICNT guidelines. Pakistan is also a party to several legal instruments related to Weapons of Mass Destruction (WMD) non-proliferation, disarmament and nuclear safety and security, including the amended Convention on Physical Protection of Nuclear Material (CPPNM). In this era of emerging technologies, Pakistan strongly believes that an internationally binding framework should be evolved to regulate different aspects of the Lethal Autonomous Weapons System (LAWS).

India, a hub of nuclear material thefts: The theft of over 200 kilograms of nuclear material over the last two decades in India poses a serious threat of nuclear terrorism, necessitating action by the global powers to address poor safety standards in the country. According to a timeline issued by The South Asia Strategic Stability Institute (SASSI), 18 nuclear materials' thefts and lost incidents were reported in India from 1994 to 2021 involving over 200 kg of nuclear material. A number of uranium/radioactive substance theft incidents in the recent past occurred in India which indicated the presence of a black market for nuclear materials inside India. The latest incidents reported are: in 2021, 6.4kg of uranium in Jharkhand and likewise 7kg of uranium in Maharashtra were confiscated by the Indian authorities. In August 2021, 250kg of uranium variant - a highly radioactive and toxic substance worth \$573 million was confiscated in Kolkata and two persons from Indian strategic organizations were arrested.

India's case of poor safety and security of radioactive material has been exclusively highlighted by Adrian Levy, a British Journalist, in his reports. He revealed that people living near the Subarnarekha Riverflowing through the Indian states of Jharkhand, West Bengal and Odisha -are routinely exposed to exceptionally high levels of radiation causing infertility and birth defects in the population. The source of this radiation are the mines, mills and fabrication plants of East Singhbum - district of Jharkhand state - where the stateowned Uranium Corporation of India Ltd is sitting on a mountain of 174,000 tons of raw material. And most dangerously, on 9 March 2022, India accidentally fired a BrahMos missile originating from Sirsa, Harvana that crashed into Mian Channu, Khanewal district, Punjab, Pakistan.

NSG bid and Pakistan: Arguably, after NTI's current nuclear safety and security ranking for Pakistan, Islamabad's case for joining the Nuclear Suppliers Group has become convincingly poised. 'All of Pakistan's export control laws are at par with international standards and the standards set by the NSG and other export control regime". India's irresponsible role of nuclear safety and security notwithstanding, the western powers have unjustifiably favoured India, thereby giving an unwarranted NSG waiver to it.

As for India, Pakistan races towards securing an NSG bid, by any sane arguments, today, Pakistan highly deserves to acquire the Nuclear Suppliers Group bid. The geopolitical western interest by no means should undermine the principle of fair and just treatment based on criteria of the NSG bid. Instead of demonstrating a biased approach vis-à-vis Pakistan's NSG bid, the western nuclear community must adopt a liberal approach in this regard.

Book burning must be banished from political discourse

There is something frighteningly true in the observation of the 19th-century German poet Heinrich Heine, which was prompted by a burning of the Qur'an in 1493 in Granada, as he warned humanity: "That was but a prelude; where they burn books, they will ultimately burn people as well." These chilling words are now engraved in the ground of Berlin's Opernplatz, commemorating the horrific burning in 1933 of 25,000 books decreed by the propaganda minister Joseph Goebbels to be "un-German." Not long afterward came the Holocaust and its mass murder of millions by the Nazis.

Recent incidents in Sweden and Denmark have highlighted that there are those who still refuse to heed Heine's cautionary words. In their distorted view, they still believe that this abject act is an acceptable and legitimate expression of freedom of speech. Well, it is not. It is simply an extreme form of incitement against what is held sacrosanct by others, and it should be universally regarded as a hate crime.

In the first incident, an Iraqi Christian immigrant burned Islam's holy book outside a Stockholm mosque on - of all days the major Muslim festival of Eid Al-Adha. In the second case, a Swedish national backed off after threatening to burn the Torah, the Jewish holy book, in front of the Israeli Embassy in Stockholm, claiming that he was not interested in setting fire to the holy book, but was merely testing the Swedish authorities to see whether or not they would enforce the law selectively regarding the burning of religious texts. That the authorities should not enforce the law selectively enjoys a broad consensus, but this does not extend to consenting to the burning of any book considered holy by any religion or belief system, or more generally any book at all.

Not only is freedom of expression not absolute, but the burning of someone else's holy or deeply meaningful book is not an expression of opinion or part of any acceptable debate in a civilized society between disagreeing individuals or groups. It is simply an act of aggression against what a book represents to others, an attack on their beliefs and on a crucial aspect of their identity. It is an attempt to demean, to establish a sense of hierarchy, to instill fear and even provoke a reaction that would serve as an excuse to accelerate the marginalization of whatever group considers that text to be sacred.

While these two Swedish cases were apparently the work of individuals, in recent years book burning has become something of a despicable political act perpetrated mainly by right-wing, antimigrant politicians and activists. More worryingly, in some cases it has been officially sanctioned. In 2010, Terry Jones, known for his extreme Islamophobic views and slurs, burned a copy of the Qur'an in his tiny Florida church, shamefully hiding behind the First Amendment. And earlier this year, Rasmus Paludan, the far-right Danish-Swedish politician and lawyer, set fire to a copy of the Muslim holy book in front of the Turkish Embassy in Stockholm to gain maximum publicity for his anti-migrant policies. There are those who dismiss these vile acts as those of negligible characters who are desperate for attention. Be that as it may, it is the lack of a firm response by their respective communities, or even the lack of any legal framework for clamping down on these actions, that makes those communities and countries complicit through their inaction.

In some European countries, burning a holy book is considered a hate crime and is punishable by law. Criminalizing such behavior as a tool to impose tolerance might be seen as counterintuitive in any civilized society where there is an expectation of respect for other people's beliefs, values and symbols, instilled from an early age at school and through other instruments of socialization, and where such respect becomes part of the society's DNA and need not be enforced. However, with the emergence of multicultural societies where the required tolerance cannot always be taken for granted, moves to curtail hate crime that are supported by law have become increasingly necessary.

Using the freedom of expression argument to defend the burning of books or, more generally, offending other people's beliefs is a lousy and disingenuous response. Yes, freedom of expression is a fundamental human right that is generally enshrined in international law. Disagreeing with others' ideas and beliefs and promoting your own is part and parcel of freedom of expression, but this has nothing in common with the sheer provocative vandalism of burning books.

proven among them prosperivalue of tolerance and the broadening of one's horizons; but it also poses challenges that need to be addressed with conviction, openness, attentiveness, flexibility and sensitivity in order to overcome them, but not with acts of violence.

By burning books, one does not make them disappear, as they will long outlive those who burn them. To torch the written word is an extension of attempts to silence people and ideas, to censor them and pretend that a book's content will disappear along with its physical destruction. There is, sadly, a long tradition of burning books, going at least as far back as 213 B.C., when Emperor Qin Shi Huang ordered the burning of all philosophy and history books from states other than Qin. In the late 15th century, the Spanish Inquisition burned about 5,000 Arabic manuscripts; in the 16th century, copies of Martin Luther's translation of the Bible were incinerated by the Catholic Church; in 1683, several books by Thomas Hobbes and other authors were put to the flames at Oxford University; and the list goes on. In some cases, the burning of people did quickly follow.

In the toxic political environment and social turmoil we currently inhabit, which polarizes communities, burning books has become the weapon of opportunists who feed and thrive on division and discord by pushing their xenophobic agenda and putting the blame for all their society's ills on those originating from other countries and subscribing to other faiths. It is a debased tool to build their power and influence and maintain their inflated egos.

This cynical exploitation of freedom of expression demands a legal, political and social response that will make burning books illegal, banishing the practice from political discourse before it can exacerbate the already fragile intercommunal relations we are witnessing in many liberal democracies, from where such inflammatory actions are threatening to spread.

Unlocking Baluchistan's Agricultural Potential

Baluchistan, Pakistan's largest province in terms of area, is a land blessed with abundant natural resources, including nearly one-third of the country's coastline, offering vast opportunities for trade and fisheries, bolstering livelihoods.

At the heart of Baluchistan's economic potential lies agriculture, which finds many suitable areas for cultivating major crops such as pistachios, almonds, apples, apricots, and more.

This sector sustains the majority of the rural population, employing around 68% of Pakistan's inhabitants and 40% of its labor force. Over the past three decades in the 20th century, agriculture has consistently contributed significantly to the national GDP. Furthermore, it plays a vital role in supplying raw materials to the industrial sector and remains a significant source of foreign exchange earnings. Notably, wheat, rice, bajra, and maize are among the main crops cultivated in Baluchistan.

Despite its vast potential, the agriculture sector faces several challenges. Rapidly growing population rates have led to a decline in the crop sector's contribution, dropping from 65% of agricultural activity in 1990-91 to 48% in 2006-07.

Baluchistan's rural population, comprising the majority, depends heavily on the agriculture sector for income generation, but limited production inhibits significant improvements in their standard of living.

Covering 44% of the country's land area, Baluchistan's total geographical expanse spans 347,190 km². According to the 2017 census, the province is home to 12,344,739 people, with a population density of 35.70 km². A significant majority, 72.5% of the population,

Various factors impede the realization of the agriculture sector's true potential in

Baluchistan. Chief among them is water scarcity, with approximately 81% of farmers reporting its damaging effects. Prolonged droughts and unsustainable use of tube wells in Northern Baluchistan contribute to rapidly declining water tables in the soil

Another challenge is the non-availability of good quality seeds. Lack of awareness prompts many rural farmers to use low-quality and uncertified seeds, resulting in nearly 40% germination failure.

Furthermore, access to agriculture lending poses a significant hurdle for Baluchistan's farmers. As highlighted in the Soil Fertility Atlas report, only 61% of farmers have access to loans. Insufficient availability of critical agricultural inputs such as fertilizers, seeds, tractors, and modern technology further hampers productivity. Additionally, the farmers' poor financial status and uneconomical landholdings, combined with plant diseases and natural climate variations, exacerbate the situation.

Baluchistan's agricultural potential is being hindered by several critical challenges that demand urgent attention from the government. While the region boasts fertile soil, farmers struggle with inadequate access to fertilizers due to the agriculture department's inability to provide proper support. Additionally, research and development efforts remain lacking, further hampering farmers' abilities to boost productivity and utilize modern agricultural practices.

One of the primary issues is the prevalent use of traditional farming equipment, exacerbated by the high illiteracy rates in rural areas. Limited access to modern technology restricts the sector's progress and stifles its contribution to the Balochistan economy.

The Zarayi Taraqiyati Bank Limited (ZTBL) was established to finance agricultural development, yet many rural farmers remain unaware of how to obtain loans for this purpose. The lack of awareness and fear of risks associated with loans hinder agricultural growth and development.

To address these issues and unlock Baluchistan's agriculture potential, it is imperative for the provincial government and agriculture minister to take immediate action. Investing in irrigation infrastructure and water resource management, as supported by the Asian Development Bank's \$100 million loan, can alleviate the water shortage and increase farm earnings significantly.

Furthermore, the government must prioritize research and development in rural areas, providing farmers with the knowledge and tools to optimize their agricultural practices. Efficient policies should be implemented to support small farmers, enabling them to raise production and gain property rights.

Encouraging agro-business for rural youth will not only create employment opportunities but also foster economic growth. The government should explore opportunities to export surplus produce and import modern agricultural equipment to improve productivity while reducing costs.

Extending the reach and functionality of the agriculture department will facilitate soil testing and better pesticide usage, further contributing to increased agricultural production.

Baluchistan's agriculture sector has the potential to elevate the living standards of its people and play a significant role in the region's economy. By addressing these challenges and implementing robust agricultural policies, the government can pave the way for a prosperous and thriving nation.

Andrey Rubley saves 3 match points to win in Hamburg

HAMBERG: Second-seeded Andrey Rubley saved three match points in the deciding tiebreaker to escape with a 5-7. 6-1, 7-6 (7) victory over Spain's Bernabe Zapata Miralles in the first round of the Hamburg European Open on Wednesday:

The Russian trailed 6-4 in the tiebreak before saving the next two points. After Zapata Miralles went back ahead 7-6, Rublev saved another as part of recording three straight points to win the two-hour, 53-minute match. In another first-round match, top-seeded Casper Ruud of Norway notched a 6-3, 1-6, 6-3 victory over Argentina's Sebastian Baez. In secondround play, fourth-seeded Alexander Zverev beat Maximilian Marterer 6-3, 7-5 in an all-German affair. Other second-round winners include Frenchman Luca Van Assche and Serbian Laslo Djere.

Australia's Alexei Popyrin converted four of five break points while posting a 6-4, 6-1 victory over third-seeded Austrian Sebastian Ofner in a second-round match at Umag. In other second-round play, seventh-seeded Matteo Arnaldi was a 6-3, 7-6 (5) winner over fellow Italian Flavio Cobolli. Also, Croatia's Dino Prizmic beat Hungary's Zsombor Piros 6-2, 6-3. Switzerland's Stan Wawrinka, the No. 6 seed, registered a 6-3, 6-2 win over Filip Misolic of Austria. Also winning first-round matches were Jaume Munar of Spain, Hungary's Fabian Marozsan, Argentina's Federico Coria and Italy's Marco Cecchinato. Atlanta Open Fifth-seeded Christopher Eubanks, competing in his hometown, rallied for a 6-7 (4), 6-4, 7-5 victory over Brandon Nakashima in an all-U.S. second-round matchup at Atlanta. Eubanks got the first service break of the match to take a 5-4 lead in the second set, then leveled the match in the next game. The third set followed the same pattern, with Eubanks getting the only break in the penalty game before sealing the victory. In other secondround action, second-seeded Alex de Minaur thrashed Thanasi Kokkinakis 6-3, 6-4 in all-Australian match. Australia's Aleksandar Vukic upset fourth-seeded Yoshihito Nishioka of Japan 4-6, 7-5, 7-6 (3), and seventh-seeded Ugo Humbert of France eliminated

Spa star Verstappen targets eighth win in row ahead of Dutch homecoming

SPA-FRANCORCHAMPS: Max Verstappen will seek to extend his and Red Bull's current sequence of record-breaking invincibility at this weekend's Belgian Grand Prix ahead of spectacular Dutch homecoming next month. After winning seven straight races and nine out of 11 this year, the Belgian-born defending double world champion, and runaway leader of this year's title race, could make it eight on Sunday and then a record-equalling nine at Zandvoort next month. Two more successive wins would take him level with former Red Bull driver and fourtime champion Sebastian Vettel's 2013 run of nine and extend his team's record sequence to 13 and then 14. Only five drivers have won seven races consecutively -Alberto Ascari, Michael Schumacher, Vettel, Nico Rosberg and now Verstappen the 25-year-old Dutchman's current form

makes it seem inevitable that

he will go on winning. Having won the last two Belgian races, he will be seeking a hat-trick as the majestic. fast and dangerous Spa-Francorchamps circuit, set in the Belgian Ardennes, hosts an F1 sprint race weekend for the first time, "Spa is my favourite track, of course," said Verstappen, echoing the thoughts of most drivers who love the sweeping fast corners of the longest circuit in use on the F1 calendar. "So, I'm looking forward to racing there and seeing the fans - it should be a fun weekend. It's our final push before the summer break." Early weather forecasts have warned of a wet weekend ahead, but that does not worry

"That'll make it a bit more interesting and chaotic," he said, oozing the kind of confidence created by driving a car that has turned him into a winning machine. Not even the best efforts of his team-mate Sergio Perez have slowed

Verstappen.

Verstappen as he extended his lead in the drivers' championship to 110 following last Sunday's victory in Hungary. where Perez was third behind McLaren's Lando Norris. Down a break in both sets, Bondar came back to deny the 16-year-old Andreeva her first quarterfinal appearance on the WTA Tour. In other action, No. 7 seed Alize Cornet of France advanced to the second round with a 3-6, 6-1, 6-3 victory over Switzerland's Viktorija Golubic.

Following her run to the round of 16 in the French Open, No. 8 seed Elina Avanesyan of Russia moved into her third WTA quarterfinal in the last two months by defeating France's Chloe Paquet 2-6, 7-5,

Hamburg European Open Posting 48 winners to Russian Yulia Putintseva's eight, Jule Niemeier - ranked No. 106 -- rallied for a 5-7, 6-3, 6-1 win over the No. 6 seed to reach the quarterfinals in her native Germany. No. 7 seed Arantxa Rus of the Netherlands dropped the second set against Nadia Podoroska of Argentina, but pulled out a 6-3, 3-6, 7-5 win. Eva Lys of Germany had no problem dispatching Panna Udvardy of Hungary 6-4, 6-1, Australia's Daria Saville defeat-Germany's Tamara Korpatsch 7-6 (6), 6-2 and Germany's Noma Noha Akugue bounced back to upend Australia's Storm Hunter 0-6, 7-6 (2), 6-4.

BNP Paribas Warsaw Open Tatjana Maria of Germany and Yanina Wickmayer of Belgium each picked up second-round victories in straight sets in Poland. Maria rolled past Clara Tauson of Denmark 6-4, 6-0, while Wickmayer cruised over Tereza Martincova of the Czech Republic 6-2, 6-2.

Medvedev withdraw from tournament Washington Open

WASHINGTON: World three number Daniil Medvedev and Australia's Nick Kyrgios have withdrawn from the U.S. Open tune-up tournament in Washington due to injury, organisers said on Wednesday.

Medvedev, who won the U.S. Open in 2021, has five titles this year with triumphs in Rotterdam, Doha, Dubai, Miami and Rome. The 27year-old Russian reached the Wimbledon semi-finals earlier this month, losing to eventual champion Carlos Alcaraz.

Defending Washington champion Kyrgios has missed every Grand Slam this year due to injuries to his knee, foot and wrist.

He has only made it onto the court once, losing in straight sets at the Stuttgart Open in June.

T20 World Cup: Ireland qualify for

Ireland have qualified for the T20 World Cup after their qualifier against Germany in Edinburgh had to be abandoned because of overnight rain.

The point is enough to ensure a top-two finish in the qualifying tournament. The Irish were already on course to qualify after victories over Italy, Denmark Jersey. and Qualification for next year's T20 tournament comes after failure to secure their place at this year's Cricket World Cup in India. Ireland face hosts Scotland in their final qualifier on Friday (15:30 BST) in a match which will decide the outright tournament winner. "While it's true that we'd rather have achieved qualification on the field today, we're delighted to have achieved our primary objective of qualifying for next year's T20 World Cup," said Ireland captain Paul Stirling.

A 26-year-old chess grandmaster, Khadem participated in a World Cup event in Kazakhstan in December 2022, without wearing the Islamic veil, which is compulsory for women in Iran. As she explained in an interview with AFP in February, she did so in support of the protest movement that erupted in Iran fol-

Haiti coach wants to see same passion against China at World Cup

ADELAIDE: Haiti coach Nicolas Delepine on Thursday said their eye-opening performance against England at the Women's World Cup will go to waste if they do not back it up when they meet China.

The Haitians were hugely impressive on their World Cup debut against the European champions in Brisbane on Saturday, dangerous on the counter-attack while restricting Sarina Wiegman's side to only a 1-0 victory.

Praise rolled in afterwards for a team ranked 53rd in the world, who went close to an equaliser, with Wiegman calling them "unpredictable, very transitional". Delepine said it was heartening, but would mean little unless they can perform to the same level against China in Adelaide on Friday. "We were very happy after the England game because we received a lot of compliments from other countries," said the experienced Frenchman. "But the message I want to say is that it will only count if we face China in the same way.

"We have to be credible and show the world the work we have put in and perform at the best level possible."

"Les Grenadieres" need a result to keep their hopes of unlikely progression to the knockout phase from Group D alive.

If they lose, and Denmark win or draw against England, their tournament will be over

Similarly, the 14th-ranked China will be eliminated with a defeat,

coupled with England winning or drawing against Denmark.

"For us, everything is possible," said Delepine. "We lost against England but we put up a good performance, it has given us good confidence against China who are a very good team.

"China has strong players, quality throughout. They have a well established game that they execute well," he added, "We need to work on our technique and tactics."

They head into the game without key defender Jennyfer Limage after a devastating knee injury against England, but buoyed by the performance of teenage attacking midfielder Melchie Dumornay, who mesmerised the crowd with her touch and ingenuity.

In a tweet, the finance minister said that US\$1.2 billion were due in fiscal year 2023-24; and US\$ 1.2 billion in fiscal year 2024-25. He said Pakistan will make interest payments only in both years.

"Chinese EXIM Bank has rolled over for 2 years principal amounts of following loans totalling US\$ 2.4 billion which are due in next 2 fiscal years: FY2023-24; US\$1,2 billion FY2024-25: US\$ 1.2 billion, Pakistan will make interest payments only in both years," he tweeted.-APP

Bahrain welcomes start of UN operation to unload safer tanker

MANAMA: Kingdom of Bahrain has welcomed the beginning of the United Nations' operation to unload 1.14 million barrels of oil from the "Safer" tanker off the coast of the Republic of Yemen, which is an important step that would prevent a marine environmental disaster in the waters of the Red Sea.

The Ministry of Foreign Affairs, in a statement, expressed the appreciation of the Kingdom of Bahrain for the unremitting efforts made by the United Nations and international endeavors that have contributed to the initiation of this crucial step, which is of great importance in confronting the environmental and humanitarian threat posed by this tanker, Bahrain News Agency reported.-APP

Shortage of gas hampering 24 hours supply to domestic consumers

ISLAMABAD: Parliamentary Secretary for Parliamentary Affairs, Saad Waseem on Thursday informed the National Assembly that due to a shortage of gas in the country, it could not be provided around the clock to even domestic consumers.

Alvi for early diagnosis of hepatitis cases

ISLAMABAD: President Dr Arif Alvi has said that as Pakistan has the world's largest population of hepatitis patients. it was a must to prioritize the screening and early diagnosis of the disease and any delayed action could lead to a devastating liver cancer epidemic.

"Presently, Pakistan has the world's largest population of patients living with Hepatitis C, a staggering 10 million cases... Without timely action, the number of HCV-infected cases in Pakistan may rise exponentially, leading to a devastating liver cancer epidemic," the president said in his message to the nation on World Hepatitis Day annually observed on July 28.

He said World Hepatitis Day was commemorated to raise awareness about the critical issue of hepatitis and related diseases in Pakistan

He said Hepatitis B and C viruses posed significant public health threats, causing immense morbidity and mortality worldwide.

"In Eastern Mediterranean Region, a staggering 80% of the hepatitis C disease burden lies in Egypt and Pakistan. While Egypt has

made commendable progress in combating hepatitis C, regrettably, our country remains a major contributor to this burden in our region," he remarked.

The president said Hepatitis C was a dangerous, silent disease, often carrying no signs or symptoms until it has done significant damage to the liver.

We must realize that individnals infected with this virus continue to carry it for years, putting them at high risk of advanced-stage liver disease and cancer, he added.

He said in order to ensure the well-being of our nation, we need to prioritize the screening and early diagnosis of hepatitis C cases. It is our duty to actively screen our entire population and promptly treat those found positive, the president added.

"The consequences are alarming: numerous deaths, liver cirrhosis cases, and a significant burden on our economy. We cannot let this happen; we must take action today to secure a healthier and prosperous future for our nation," he advised.

He said on World Hepatitis Day, the nation should reaffirm its commitment to making hepatitis prevention, control, and elimination a national priority.-
